

ORDINANCE NO. 2017-5

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF SOCIAL CIRCLE, GEORGIA, TO APPOINT MEMBERS TO THE BOARD OF DIRECTORS OF THE MAIN STREET COMMISSION WHICH WAS ESTABLISHED TO PROMOTE AND REVITALIZE THE CITY'S CENTRAL BUSINESS DISTRICT.

WHEREAS, the duly elected governing authority of the City of Social Circle, Georgia is the Mayor and Council thereof;

WHEREAS, this Ordinance Amendment shall be known as the "Social Circle Main Street Commission Board of Directors Appointment Ordinance"; and

WHEREAS, the purpose of this Amendment is to appoint a board of directors to the Social Circle Main Street Commission which was recently established to promote and revitalize the downtown business district of the City of Social Circle.

IT IS HEREBY ORDAINED BY THE GOVERNING AUTHORITY OF THE CITY OF SOCIAL CIRCLE, GEORGIA AS FOLLOWS:

**Section 1. Purpose:** The attached Exhibit "B" is hereby added as an amendment to the ordinance approving the Main Street Commission for the City of Social Circle approved at the February 21, 2017 meeting.
