Take a present day stroll through Social Circle's past



City of Social Circle Q&A:



Q: How do I obtain a police or accident report?

A: Police and accident reports can be picked up at the Social Circle Police Department Monday through Friday from 8:30 a.m.- 5:00 p.m. They may also be emailed to involved parties. A request will have to be made by phone and personal identifiers confirmed prior to an emailed report being sent. Requests can be made by contacting the SCPD at (770) 464-2366. Accident reports can also be purchased online by going to buycrash.com and utilizing the case number provided by the officer at the time of the accident.

Q: What if I have an open records or criminal history request?

A: If an individual wants to obtain a report in which they are not an involved party, an open records request will need to be filed with City Clerk Susan Roper utilizing the City's Open Records Request form. This form also would be used to request body camera footage. Criminal history requests can be processed at the police department Monday through Friday from 8:30 a.m.- 5:00 p.m. A signed consent form and a cash fee of \$20.00 is required.
