The collection of household bulk items service has been suspended at this time. Do not put extra garbage bags outside of the cart. You can schedule a special pick up with the City for an additional fee, if needed.

## Senior Center

The Senior Center is closed though April 30. They are providing frozen and shelf-stable food items to members on Mondays.

## **Elections**

The Georgia Secretary of State, Brad Raffensperger, announced that the March 24 election is being moved to May 19, the date of Georgia's other primary elections. This does include our local election for the District 3 City Council position. All votes that have already been cast will be counted for the May 19 election. # Gov. Kemp, UGA's SBDC Provide Overview of CARES Act Funding

Congress passed Coronavirus Aid, Relief, and Economic Security (CARES) Act, a \$2.2 trillion stimulus package, and SBA programs designed to lead the way in small business recovery. Yesterday, Governor Kemp announced the Georgia Department of Community Affairs, the Georgia Department of Economic Development, and the Small Business Development Centers (SBDC) are partnering to make sure that every small business in Georgia is aware of these programs.
