# City of Social Circle Q&A:

Q: How do I set up a new utility account? A: To have services connected you will need:

- A legal document of residency, such as a lease or closing documents.
- A completed new utility service application, posted on www.socialcirclega.gov.
- A copy of a customer's driver's license. A deposit must be paid before services will be connected under the new account. The deposit amounts are \$100 for water and \$200 for gas services. The City provides water, sewer, gas, and trash and recycling pick-up.

Applications for services and accompanying documents must be either emailed in a pdf format or brought to City Hall at the drive-thru window to have utility services set up. All emailed documents can be sent to jturner@socialcirclega.gov. Service cannot

be set up online.

# **Call BEFORE You Dig!**

If you plan to dig around buried gas piping, first dial 811 or call the Georgia One Call Center at 800-282-7411 three (3) days before you or your contractor dig so that all buried cable may be located. This is a free service. Flags mark



where cables are buried. Flag colors represent various types of buried lines.

Red denotes electric power lines, cable, conduit, and lighting cables. Orange is for telecommunication, alarm, or signal lines, cable, or conduit. Yellow represents natural gas, oil, steam, petroleum or other gaseous or flammable materials. Green means there are

sewers and drain lines. Blue is for drinking water. Purple is for reclaimed water, irrigation, and slurry lines. Pink shows temporary survey markings and unknown facilities. White denotes proposed excavation limits or route.
