JOB SUMMARY

This position is responsible for the operation of fire apparatus. Responding to emergency scenes to perform fire suppression, emergency medical, rescue, and hazardous materials mitigation duties. An incumbent in this position may be designated "Firefighter/EMT Basic, Intermediate, Advanced, or Paramedic"

MAJOR DUTIES

Firefighter

- Follows department policies and SOG's.
- Responds to calls for assistance and provides appropriate services as required; portrays a professional attitude and maintains a positive public image.
- Understands the operation and safe use of all equipment on the apparatus; inspects and maintains all equipment per department policy.
- Follows the department Incident Command System.
- Participates in cleaning and maintaining station facilities, grounds, equipment, and apparatus. Any deficiencies shall be reported to their immediate supervisor as soon as the problem is found. Ensures that all personal equipment is in a constant state of readiness for calls.
- Participates in fire prevention and public service activities.
- Maintains basic knowledge of streets and hazard locations as identified in the assigned district.
- Shows commitment to team results by being able to work with and for others and by communicating effectively with co-workers.
- Remains familiar with basic knowledge of computer equipment and programs used by the department.
- Meets all training requirements as assigned by the department.
- Acquires and maintains specialized training/certification as required.
- Relays necessary information to oncoming crew at shift change.
- Signs in and out daily.
- Performs other duties as assigned.
- Responds to calls for assistance involving emergency medical situations, including cardiac problems, breathing difficulties, childbirth, strokes, diabetic seizures, sports and automobile injuries, and other traumatic and medical incidents

Driver

- Ensures the safe operation and maintenance of all apparatus and equipment assigned to that driver; ensures that all equipment is in a state of constant readiness.
- Retains thorough knowledge of streets and hazard locations as identified in the assigned district.
- Acquires and maintains specialized training/certification as required but not limited to:
 - a. Practical Fire Ground Hydraulics
 - b. Pump service testing

- c. Pressurized Water Systems
- d. Fighting Fires in Sprinkled Buildings
- Accepts any additional responsibilities and duties for specialized apparatus and equipment.
- Gathers pertinent information and complete reports on incident calls, hydrants and pre fire plans etc. as required by their supervisor.
- Retains a thorough knowledge of computer equipment and programs used by the department.
- Completes a daily check list that complies with department truck check list.
- Reads and follows NFPA 1002.
- Performs related duties.

KNOWLEDGE REQUIRED BY THE POSITION

- Knowledge of fire department operational policies and procedures.
- Knowledge of current and accepted firefighting practices.
- Knowledge of Georgia Firefighter Standards and Training Council compliance standards.
- Knowledge of departmental and city policies and procedures and related federal, state, and local guidelines.
- Knowledge of city streets and geography.
- Knowledge of computers and job related software programs.
- Skill in operating emergency vehicles and equipment.
- Skill in the analysis of problems and the development and implementation of solutions.
- Skill in the preparation of clear and precise administrative reports.
- Skill in oral and written communication.

SUPERVISORY CONTROLS

The Fire Lieutenant assigns work in terms of general instructions. The supervisor spot-checks completed work for compliance with procedures, accuracy, and the nature and propriety of the final results.

GUIDELINES

Guidelines include department standard operating procedures, city ordinances, NFPA recommended standards, and local, state and federal laws. These guidelines require judgment, selection and interpretation in application.

COMPLEXITY/SCOPE OF WORK

- The work consists of varied equipment operation and fire suppression and prevention duties. The variety of tasks to be performed contributes to the complexity of the position.
- The purpose of this position is to operate assigned apparatus and equipment in response to emergency and non-emergency calls for service. Success in this position contributes to safety of life and property.

CONTACTS

- Contacts are typically with co-workers, other city employees, representatives of other fire departments, law enforcement personnel, and members of the general public.
- Contacts are typically to provide services, to give or exchange information, to resolve problems, or to motivate or influence persons.

- The work is typically performed while sitting at a desk or table or while intermittently sitting, standing, walking, bending, crouching or stooping, The employee frequently lifts light and heavy objects, climbs ladders, distinguishes between shades of color, and utilizes the sense of smell.
- The work is typically performed in an office, firehouse, and outdoors, occasionally in cold or inclement weather. The employee may be exposed to extreme heat, smoke, falling materials, noise, dust, machinery with moving parts, contagious or infectious diseases, or irritating chemicals. Work requires the use of protective devices such as masks, goggles, and gloves and of specialized fire equipment.

- Possession of or ability to readily obtain a valid driver's license issued by the State of Georgia for the type of vehicle or equipment operated.
- Ability to meet current requirements set forth by the National Fire Protection Association and the Georgia Firefighter Standards and Training Act.
- A minimum 18 years of Age.
- NIMS Compliant (as required by national standard, must be obtained in 6 months)
- Certified Firefighter (as required by Ga. Firefighter Standards and Training Council)
- NPQ Firefighter II 2008 Ed. (must be obtained in 12 months)
- Meet all Requirements of Section 4-09 Firefighter
- State of Georgia EMT-B or Higher by DHR and State Office of EMS Standards preferred or ability obtain appropriate state EMS certification at level of EMT-A within 18 months for continuation of employment
